8. MOTION ON PRIORITIZATION OF DISBURSEMENT OF THE COUNTY BURSARY FUNDS

(HON. MUMINA KONSO)

That, Aware that most of the Secondary and College/ University Students are at home due to non-payment of School Fees; Further Aware that the current drought situation has eroded the potential of locals to pay school fees due to poor market price of the livestock depended on by most of the people around the county; acknowledging that the County Government has allocated ksh.35M for disbursement as bursaries for the needy student in the current Financial year 2017/2018; Worried that delayed release of the bursary fund by the County Government may result in denying the local student access to education as guaranteed under Article 43(10(f) in the Bill of Rights; This County Assembly recommends that the County Government to prioritize the disbursement of bursary funds urgently to retain the student in the school.
