**8. MOTION ON MANAGEMENT AND PROTECTION OF GRAZING PATTERNS/
BLOCKS SO AS TO HAVE RESERVE FOR PASTURE AND WATER DURING DRY SEASON
(BY HON. ISACK ABDUBA FAYO)**

THAT, Appreciating that Article 60 (1) of the Constitution of Kenya, 2010 provides that land in Kenya shall be held, used and managed in a manner that is equitable, efficient and productive; Further Appreciating that the provisions of Article 63 states that any unregistered community land shall be held in trust by the county governments on behalf of the communities for which it is held and community land shall not be disposed of or otherwise used except in terms of legislation specifying the nature and extent of the rights of members of each community individually and collectively; Acknowledging that the county planning frameworks is provided for clearly in the County Government Act Part XI; Noting that inter county planning can be driven by contiguous counties at the county level or steered by the national government if the counties show that interest; Appreciating that the Counties will jointly enforce/implement the plans for resources along common boundaries; Acknowledging that the County spatial planning as provided in the County Government Act Section 110, will give the spatial configuration of the county, linking economic and social development to space requirements, indicate the land uses for the different areas and help counties control and regulate this uses including county assembly legislation to introduce grazing fees, seasonal royalties/fees especially for livestock from other counties once such land use has been planned and the plan approved by the county Assembly; this County Assembly urges the County Executive Committee Member for Lands, Physical Planning, Works and Urban Development to urgently carry out planning of the entire county in order to solve the problem of influx of pastoral communities and their livestock across the county boundaries hence reserve pasture and water for our livestock during dry seasons.

MOTION ON THE ALMASI CHILDREN HOME SUPPORT BY THE COUNTY GOVERNMENT (BY HON. STELLA NTUTI)

THAT, Acknowledging that the provisions of Article 54 (1) of the Constitution of Kenya, 2010 guarantees that any person with disability is entitled to access educational institutions and facilities for persons with disabilities that are integrated into society to the extent compatible with the interests of the person and to access materials and devices to overcome constraints arising from the person's disability; Concerned that parents with disabled children are stigmatized and are also discriminated against by the society which results to further depression; deeply concerned that large percentage of parents with children with disabilities and mostly headed by single parents live in abject poverty living from hand to mouth/hardly access medical services, let alone providing education for their children; Worried that these children would not access basic education in this era of free primary education as the only institution they depend on was closed due to lack of teachers because of payment challenges, lack of learning materials and other basic needs; this Assembly urges the County Executive Committee Member for Education, Sports, Culture, Gender and Social Services to re-open and equip the ALMASI Children Village to relieve burden from parents who struggle with their children with special needs.
