8. MOTION - ON DROUGHT AND FAMINE ACROSS THE COUNTY

(HON. LEMANTILE DAVID)

That, Aware that there has been severe drought consistently for the last one and half years all over the county; Further Aware that this severe drought has cost the lives of both the livestock and to some extent the lives of the people due to excess famine; Appreciating that Article 43 (1) (c) (d) of the Constitution of Kenya states that "every person has the right to be free from hunger, and to have adequate food of acceptable quality; and to clean and safe water in adequate quantities; acknowledging that the drought has led to the migration of pastoralists with their livestock to the neighboring counties in search for pasture; Worried that if there is no urgent intervention, the drought and famine will be more drastic and cost more lives of both the Livestock and the people; This County Assembly Resolves that:

1. The County Government declares the current drought a disaster and come up with urgent short term mechanisms by:
 - a. release funds to facilitate provisions of emergency food supplies and water tracking to the people all over the county having in mind that most pastoralists have migrated with their livestock to the neighboring counties of Marsabit, Wajir, Laikipia and Samburu;

- b. The County Executive to liaise with the relevant National Government agencies/departments to urgently initiate off take programme with the aim to buy the affected animals before they become emaciated and lose their value. This also helps pastoralists to recover some money from their livestock and utilize it to meet basic needs and strengthen the community's ability to recover from effects of the drought; and
2. Pursuant to the provision of Section 14 (1)(b) of the County Government Act, 2012, the County Assembly approves the appointment of the following Members into County Assembly Ad-Hoc Committee on Emergency:-
 1. Hon. David Lemantile - Chairperson
 2. Hon. Ali Dhima Duba
 3. Hon. Yarrow Hassan Wario
 4. Hon. Mohamed Jirmo Golicha
 5. Hon. Mumina Konso

The Emergency Committee shall

- a) Comprehensively assess the drought and famine situation;
- b) Inquire into distribution of emergency relief supplies from the National Government and recommend ways to create synergy on the interventions initiatives of both levels of government;
- c) Monitor on the provisions of other emergency efforts by both levels of Government; and
- d) Bring a Report to the County Assembly giving recommendations on ways to improve the food security in the county in a month.
